Allotment Order

An amount of Rs 3,56,57,500/- (Rupees Three Crore Fifty six Lakh Fifty Seven Thousand Five Hundred) only is hereby sub-allotted to the account of 59 nos. of CLRC for Escort and Transport allowances to CWSNs,

- A). Eligibility for getting Escort or Transport allowance (@Rs.2,500/- each), are as follows.
 - 1) One CWSN may get only one allowance either Transport or Escort.
- 2) Boys with Autism Spectrum Disorder, Cerebral Palsy, Multiple Category, Hearing impaired and all girls CWSNs (except SLD) are eligible for Transport Allowances.
- 3). Boys with Mental Retardation, Blindness and the Boys Problem with Lower extremity are eligible for Escort allowances.
- B). All the CWSNs who are enrolled (up to class-VIII) in formal Schools , SSK, MSK, and ICDS Centre are eligible for getting Transport / Escort allowance an amounting to @Rs.2,500/- each.

The allotment is made out of SSM Fund for the year 2015-16. Circle wise flow of fund and the name of the circle for which allotment is made is annexed herewith.

The fund so allotted should be utilized observing SSM norms stipulated by the Govt. of India & financial rules of Govt. of west Bengal.

Necessary utilization certificate of the allotted fund in the prescribed format should be furnished to this office immediately after incurring expenditure and unutilized fund (if any) should be refunded to the District Project Officer, SSM, Bardhaman by Demand Draft drawn in favour of SSM, Bardhaman payable at Bardhaman. Original vouchers and other related papers should be kept with the Office concerned and should be produced before audit as and when required. No diversion of the fund will be accepted.

Punjab National Bank , Main Branch, Bardhaman is being advised to remit the fund accordingly.
